Today in Columbus History: On June 7, 1870, an announcement appeared in *The Weekly Sun* for the marriage of Samuel Green Murphy to Helen Waynman Swift, eldest daughter of Columbus industrialist George Parker Swift and his wife Adelaide Jewett Swift. The date given for the marriage is wrong. The "18th instant" (meaning current month) would have been June 18 – and the paper was published on June 7. They were married on June 1. J.R. McIntosh, minister who married them, was the bride's uncle by marriage (married to Adelaide's sister Caroline). The other pastor was the father of Noble Leslie DeVotie, one of the founders of the S.A.E. fraternity.



George Parker Swift had moved to Georgia in 1832. Elder sister Deborah had married William J. Waynman, who built a textile mill in Upson Co. As fate would have it, Swift got drawn into the textile business because of a terrible accident. In 1835, when Waynman fell off the roof of his mill and died, Deborah asked George to come help run the mill. Swift created a number of textile mills in Upson, but after the war he moved his family to Columbus, where there was a larger cotton market and better water power. By 1867, Swift and business partners Samuel G. Murphy and J. J. Grant had organized the Muscogee Manufacturing Company. Thus began the impressive textile legacy of the Swift family of Columbus, GA.
