
Today in Columbus History: On August 18,1877 a legal notice appeared in the *Columbus Daily Times* regarding the estate of John M. Starke, deceased. Born in 1823, in Barbour Co. AL, John was the second youngest of Samuel Carr Starke and Ann Mickle Starke's seven children. In 1853 he married Mary Grier, the daughter of wealthy Stewart County planter James Grier, who died a couple of years later. Mary, as an only child, inherited her father's estate; John profited as well: in the 1860 census John's total estate was valued at \$300,000. Then came the Civil War...John enlisted in 1863 but served only for one day; he hired a substitute to take his place. The Starkes moved to Columbus in 1865, buying land and a house (currently located at 1410 Starke Ave.) in Wynnton. There the Starkes raised their 2 children, Sally and John T. John M. died in 1877: his wife Mary, in 1882. They are both buried in Linwood Cemetery. Shortly after Mary's death. The house on Starke Ave. sold to H.H. Epping. By 1913 it was the property of Rhodes Browne.

This photograph, taken in 1913 (according to a handwritten note on the verso), shows the house that still stands at 1410 Starke Avenue before the ambitious remodeling undertaken in the 1920s by Nina Young Browne (Mrs. Rhodes Browne) and Columbus architect T. Firth Lockwood. Nina and Rhodes Browne, along with their daughter, Marjorie, occupied the house as early as the fall of 1913. Marjoric Browne Hunt, who married her first husband, Weyman Strother, in the house in 1914, owned the property until her death in 1937. According to a grid drawn for the Muscogee Real Estate Company in 1911, the house was originally situated (at least partially) in the middle of what is now Starke Avenue—a matter of some 25 or 30 yards from the structure's present location. Evidently, the structure was moved to its present location between 1911 (date of the grid) and 1913 (year that the Brownes took occupancy).
